Item #7. Brandon Frison's Report (raised by Jamie Turbet)

Working on summarising Dropbears exit interview feedback.

Item #8. Reshuffle of board positions (raised by Jamie Turbet)

- Several stakeholders have raised concerns that the Head Coach of Dropbears and Chair of the board is the same person
- Since this board only has a month left and Luke is stepping down, there is not a lot of benefit to a reshuffle right now. There are other examples of organisations who have board members acting in staff roles.
- QA should be active in promoting good governance, instead of takeing advantage of coincidence. We are seen as leaders in the international quidditch community and within Australia and should act like it. It is not good practice for one person to hold too much power within the community.

Item #12. Merchandise agreements (raised by Jamie Turbet)

- We would like to do a profit sharing system for people who design merchandise for us. 50% is the suggested starting point.
- The idea is good, but 50% might be too much. There needs to be a consist profit share across every artist, especially with a small community. We could have three tiers of profit shares. Or go to the next profit price after a set. Also makes it easier for the board instead of negoitating with each artist individually.
 - This will not apply to Dropbear or event merchandise.
 - Will be a negotiation and will between 25-50%. Will start with community.
